13.06.03.01 Senate Executive – senate membership

Moved (Brodbeck/Galotta): that Senate approve the Senate membership for the 2013 senate year as submitted.

Lajoie commented that the part-time sessional representatives were not included.

Marasco confirmed Michael Lajoie/Luci Wurdemann as part-time sessional representatives and commented that the senate package was circulated prior to receiving final notice.

13.06.03.03 Senate Executive – Deputy Speaker

The Speaker informed the Senate there were two nominations submitted in advance. After a ballot vote, Professor Dave Galotta was pronounced as the Deputy Speaker for the 2013 senate year.

13.06.03.07 Academic Regulations & Petitions – revised terms of reference

Moved (Lajoie/Marasco): that Senate approve the following changes to the terms of reference of the Academic and Regulations and Petitions Committee (ARP) as follows:

## From:

- a) The committee shall recommend candidates to Senate for the conferring of degrees, diplomas and certificates;
- b) To make exceptional admission decisions including petitions for admission (i.e., lacking admission requirements), re-admission, and substitution of credit;
- c) To advise on admission policies and practices of the University;
- d) To advise with respect to transferability of credits from other educational institutions.
- e) To consider and make recommendations to Senate on such matters as may be referred to it.

## <u>To:</u>

- a) The committee shall recommend candidates to Senate for the conferring of degrees, diplomas and certificates;
- b) To make exceptional admission decisions including petitions for admission (i.e., lacking admission requirements), readmission;
- c) To make exceptional transcript decisions based on honourable course withdrawals, substitution of credits, late registration, etc:
- d) To advise on admission policies and practices of the University;
- e) To advise with respect to transferability of credits from other educational institutions.
- f) To consider and make recommendations to Senate on such matters as may be referred to it.

## 13.06.04 DECISION ITEMS (for action)

13.06.04.01 Office of the Registrar – Algoma University Spring Graduands 2013

Moved (Johnston/Reed-Elder): that Senate admit to their respective degrees in-course the students as submitted who have completed all the requirements of their respective degrees and that diplomas for the degrees be awarded at Spring Convocation 2013 for the conferring of degrees.

Galotta asked the Registrar to comment on any notable trends with graduates.

Marasco stated that there was an increase of 20 graduates this year as compared to last year, however, not as many as the previous year. He added that the convocation report was circulated to Senate

## 13.06.04.02 Office of the Registrar – AU/LU Spring Graduands 2013

Moved (Broad/Lajoie): that Senate admit to their respective degrees in-course the students as submitted who have completed all the requirements of their respective degrees and that diplomas for the degrees be awarded at Spring Convocation 2013 for the conferring of degrees.

The Registrar commented that this would be the last year of Algoma/Laurentian graduates.

13.06.04.03 Office of the Registrar – certificates

Moved (Marasco/Reed-Elder): that Senate approve the students as submitted who have completed the requirements of their respective certificates and that certificates be awarded at Spring Convocation 2013.

13.06.04.04 Decanal Review/Search Committee – notion of motion

Moved ( / ): that Senate approve of the change to the preamble of the Decanal Review/Search Committee as follows:

#### From:

Senate shall recommend to the Board a candidate for appointment or reappointment as Academic Dean, normally once every three years. Senate shall select a Decanal Review/Search Committee to assist in this task; the Committee shall be formed not less than <u>nine</u> months prior to the conclusion of the serving Dean's term of office. The committee shall consist of:

- a) One academic staff representative from each Division,
- b) One representative from the sessional faculty,
- c) One staff representative,
- d) One student representative,
- e) The Registrar,
- f) The President (non-voting)

To:

Senate shall recommend to the Board a candidate for appointment or reappointment as Academic Dean, normally once every three years. Senate shall select a Decanal Review/Search Committee to assist in this task; the Committee shall be formed not less than <u>twelve</u> months prior to the conclusion of the serving Dean's term of office. The committee shall consist of:

- a) One academic staff representative from each Division,
- b) One representative from the sessional faculty,
- c) One staff representative,
- d) One student representative,
- e) The Registrar,
- f) The President (non-voting)

#### <u>Rationale:</u>

This revision is necessary in order to allow the preamble of the membership to be consistent with the terms of reference of the Decanal Review/Search Committee, specifically, the 'appointment clause'.

'Senate shall recommend to the Board a candidate for appointment or reappointment as Academic Dean, normally once every three years. Senate shall select a Decanal Review/Search Committee to assist in this task; the Committee shall be formed not less than twelve months prior to the conclusion of the serving Dean's term of office.'

## 13.06.04.05 Appeals Committee – revised policy (A8)

Moved (Deluca/Shaw): that Senate approve the revised Academic Appeals Policy as submitted.

Galotta asked for someone from the Appeals Committee to highlight the changes to the current policy.

DeLuca commented that the policy has not been updated since 2008. There are no significant changes made to procedures – the revised terms of reference clarifies the policy in an effort to align it with other university policies.

Ross commented that the procedures for academic appeal is onerous for the students.

The President spoke to the issue of student retention. He commented that beginning this fall 2013, we could expect up to 300 new domestic students. A major struggle for the institution is to retain students. Retention rates are low compared to other institutions. He indicated that an email would be circulated with respect to a new faculty role – looking for someone who is interested in taking on the role of participating in retention initiatives and engaging in research – this would mean course reduction for the faculty member.

He added that the purpose of the faculty role would be to understand students and the needs that they present both academic and non-academic. The advantage is that we will have the support of faculty who have the knowledge of our student base in an effort to analyze problems and react in a pro-active manner.
