16.10.04 DECISION ITEMS (for action) 16.10.04.01 Curriculum Committee

Moved (Imre/Antunes): that Senate approve the following revised course as submitted by the Department of Biology:

BIOL 4206 Concepts in Health Informatics

This course provides a broad introduction to health informatics, the field concerned with the application of information and communication technology (ICT) for the acquisition, storage, management and use of information in health care. The course provides an overview of current developments, issues and challenges in the emerging field of health informatics and covers various underlying themes including proper use of information technology, appropriate data entry, data privacy concerns, decision support, electronic health/medical records, ethical issues, etc. The course, considering viewpoints in public health, nursing, ICT in medicine and computer science, is a series of lectures supported by self-directed learning which culminates in a mini conference prepared by the students presenting selected studies of interest. Pre-requisite: one of COSC 1046, 1701, 1702, BIOL 2056, 2996 or PSYC 2127 or permission from the instructor. (LEC 3) 3 cr

BIOL 3556 Concepts in Health Informatics

This course provides a broad introduction to health informatics, the field concerned with the application of information and communication technology (ICT) for the acquisition, storage, management and use of information in health care. The course provides an overview of current developments, issues and challenges in the emerging field of health informatics and covers various underlying themes including proper use of information technology, appropriate data entry, data privacy concerns, decision support, electronic health/medical records, ethical issues, etc. The course, considering viewpoints in public health, nursing, ICT in medicine and computer science, is a series of lectures supported by self-directed learning which culminates in a mini conference prepared by the students presenting selected studies of interest. Pre-requisite: one of PSYC 2127, 3256, 3286, BIOL 2056, 2996, or SOCI 2127 or permission of the department. Students may not retain credit for BIOL 3556 and BIOL 4206, or any special topics course in PSYC or SOCI where the topic was Health Informatics. (LEC 3) 3 cr

Rationale:

This was originally a 4th year elective course. However, having found that 3rd year students have enough background to undertake this course successfully, and no longer needing it at the 4th year level, this course is being revised to more accurately reflect the content needed for an introductory class for students from multiple disciplines at the 3rd year level.

Moved (Burnett/Friyia): that Senate approve the following new course as submitted by the Department of Biology:

BIOL 3137 Reading Darwin and His Contemporaries

In this course students will read Charles Darwin's On The Origin of Species and study him in his natural habitat – the Victorian Period – to see his ideas in conversation with those of his contemporaries. Students will explore how significant writers and thinkers of the time, working in fiction, poetry, criticism, philosophy, and psychology, take up Darwin's ideas and his theory of evolution and inquire into their implications for civilization, culture, self-knowledge, and our perception of the natural world. Students may not retain credit for more than one of the following BIOL 3137, ENGL 3137 and ENGL 3135. Prerequisites: ENGL 1006/1007 or upper year standing in Biology or permission of the department. (SEM 3) (3 cr)

<u>Rationale:</u>

The Departments of Biology and English recognize this can be a valuable course for students in both disciplines, given that Charles Darwin is an important figure in both the history of science and biology and the history of English literature. This course will be cross-listed with ENGL 3137.

ENGL 2356 Contesting Modernity – Joseph Conrad and Friedrich Nietzsche

This course focuses on the dialogue between a philosopher, Friedrich Nietzsche, and a novelist, Joseph Conrad. It examines how philosophy and fiction use different forms to make inquiries into humanity, truth, morality, and individuality, among other topics. The works of the two writers embody significant criticisms of the modern world in revaluing the traditions of philosophy and fiction. Prerequisite: ENGL 1006/1007 or permission of the department. (SEM 3) 3 cr

ENGL 2356 Contesting Modernity – Joseph Conrad and Friedrich Nietzsche

This course focuses on the dialogue between a philosopher, Friedrich Nietzsche, and a novelist, Joseph Conrad. It examines how philosophy and fiction use different forms to make inquiries into humanity, truth, morality, and individuality, among other topics. The works of the two writers embody significant criticisms of the modern world in revaluing the traditions of philosophy and fiction. Prerequisite: 6 credits from the following ENGL 1006/1007, PHIL 1116/1117, 1046. Students may not retain credit for both ENGL 2356 and PHIL 2356 (SEM 3) 3 cr

Rationale:

The Departments of English and History/Philosophy recognize that Joseph Conrad and Frederick Nietzsche are important figures in the history and development of philosophy and literature. Students in both disciplines can benefit from taking this course. It also expands the number of philosophy courses available in this institution.

PHIL 2356 Contesting Modernity – Joseph Conrad and Friedrich Nietzsche

It examines how philosophy and fiction use different forms to make inquiries into humanity, truth, morality, and individuality, among other topics. Prerequisite: 6 credits from the following PHIL 1116/1117, 1046, ENGL 1006/1007. Students may not retain credit for both PHIL 2356 and ENGL 2356 (SEM 3) 3 cr

Rationale:

The Departments of English and History/Philosophy recognize that Joseph Conrad and Frederick Nietzsche are important figures in the history and development of philosophy and literature. Students in both disciplines can benefit from taking this course. It also expands the number of philosophy courses available in this institution.

16.10.04.02 Fair Dealing policy and Fair dealing FAQs

Moved (Hernden/McCutcheon): that Senate rescind the Fair Dealing Policy and Fair Dealing Frequently Asked Questions (FAQs) that it approved in June 2011.

Rationale:

- 1. The policy and FAQ are now completely out of date and are a risk to the university as worded. Since 2010-2011, the copyright landscape has changed dramatically, including a complete overhaul in 2012 to the *Act* (see #2 below).
- There have been a number of favourable legal and Copyright Board of Canada decisions supporting broad and robust
 interpretations of the Fair Dealing section updates to the Copyright Act (R.S.C., 1985, c. C-42) made by the Copyright
 Modernization Act S.C. 2012, c. 20. See: http://www.michaelgeist.ca/2016/02/fairness-confirmed-copyright-board-deals-another-blow-to-access-copyright/
- 3. The version of AUCC's (now Universities Canada's) Fair Dealing Policy and FAQs upon which our Fair Dealing Policy and FAQs are based are not current and Universities Canada no longer supports them. In fact, Universities Canada has backed away from offering a sample policy and FAQ, only providing general guidelines for institutions to craft their own based on each institution's expertise and/ or legal advice.
- 4. Access Copyright's trial lawsuit against York University is still ongoing. Court cases tend to be where the limits of the fair dealing principle are defined, so this decision will be important for whatever we do concerning copyright and fair dealing.

5. All members of the university campus are bound by the terms of the *Copyright Act (R.S.C., 1985, c. C-42)* even without a policy in place. Such a policy tends to enhance the protection of a university from litigation, but only if it is kept current and the university can show that it took the steps that it said it would take in the policy. That is to say, it at least implies a coherent, pro-active, and ongoing regime of education and enforcement. Therefore we would be better to indicate what we do without going out on a limb with a positive policy. Currently, the following areas are most impacted by copyright issues:
